Chobham Rugby Club is supportive of draft policy HA1 (06).

The Club have been actively engaged with both Chobham Parish Council and SHBC for a number of years with regards to the planned relocation of Chobham Rugby Club, due to space constraints arising from growing membership and stringent RFU and Sport England requirements, and the release of our current site at Fowlers Wells in Chobham to fund the relocation and help meet the housing needs of the local community.

It is clear that provision of recreational space within Chobham Parish and the wider borough is a must and as such draft policy HA1 (06) makes it clear that release of Fowlers Wells is predicated on identifying a relocation site for Chobham Rugby Club. To that end the Club is in regular communication with Chobham Parish Council regarding progress of the land search and have been, and continue to be, in active communication with local landowners in identifying a suitable site with all efforts being made to achieve a relocation as soon as practicable. This could be within 5 years, but if not, it will be achieved in the life of the plan.
