

Neighbourhood Planning Surrey Heath Borough Council Strategic Policies

There is a list of basic conditions in the Town and Country Planning Act 1990 that must be met by a Neighbourhood Plan before it can be successful at independent examination and ultimately “made” by the local planning authority. One of these basic conditions is that any draft Neighbourhood Plan must be in “general conformity” with the strategic policies contained in the development plan for the Borough. The National Planning Policy Framework (NPPF) sets out that the local planning authority should clearly set out the strategic policies for their area.

Outside of these strategic policies Neighbourhood Plans can devise their own local policies for their areas. The Neighbourhood Plan only has to be in general conformity with the strategic elements of a Local Plan. Once a Neighbourhood Plan has been found to be in conformity and is brought into force, the policies it contains take precedence over existing non-strategic policies in the Local Plan for that neighbourhood, where they are in conflict (NPPF paragraph 30).

In order to guide the preparation of Neighbourhood Plans, it is necessary to clarify which policies the Council considers to be strategic for the purposes of Neighbourhood Planning. This takes into account the broad guidance in the NPPF and PPG. These are set out below.
